Hall Co. in Fort Worth is 335-3325. He has never heard of MILLER contacting anyone at N. C. Hall Company in Fort Worth.

Informant further advised that phone number 336-3511, is a straight line to the Sport Desk at the Fort Worth Star Telegram. Nearly all players and bookmakers use this number to get the latest results on sporting events.
