## DETAILS:

AT DALLAS, TEXAS

Sergeant ROY L. VAUGHN, Metro Unit, Dallas Police Department, advised on March 28, 1973, he had received information that the subject had suffered a recent heart attack and was confined to the intensive care unit of Baylor Hospital in Dallas, Texas. Sergeant VAUGHN also advised that in addition to the heart attack, he understood the subject also suffered brain damage; however, this is unconfirmed at this time.

Sergeant VAUGHN was recontacted on April 3 and April 16, 1973, and advised that the subject had been released from Baylor Hospital and was recuperating at home. He said at this time that since the close of the past football season, the subject has not been doing any bookmaking.

ADMINISTRATIVE

DL 466-C-TE advised SA F. VINCENT CESARE on 2/27/73, that the subject had recently suffered another heart attack and was assigned to a Dallas hospital, identity of which unknown at the time.

DL 845-C-TE advised SA F. VINCENT CESARE on 3/23/73, that the subject is still confined to the intensive care unit at Baylor Hospital in Dallas and that in addition to a heart attack, he had suffered brain damage.

In view of the subject's physical condition and the fact that he has allegedly ceased bookmaking operations, leads are not being set out at this time to identify subscribers of telephone numbers called from the subject's home telephone as reflected on most current bills.
