## Synopsis:

JFK Law 10(a)2

[REDACTED] ESCO holds ICC Certificate # MC-647 authorizing operation in the tri-state area of Ohio, Pennsylvania and West Virginia. [REDACTED]

[REDACTED] BAKER indicted by FBI, Pittsburgh, for violation Title 29, U. S. Code, Section 186, 9/21/59 in three counts for accepting a total amount \$525 from CALLAHAN. [REDACTED]

[REDACTED] ARMAND CARLOMAGNO claims to have paid his own bill at Belcrest Hotel, Detroit, Michigan, in 9/57. Disclaims knowledge of receipt of registered mail by WEINHEIMER or WEINHEIMER's paying money to BAKER. Mrs. PERLAKY recalls addressing envelopes to WEINHEIMER at Des Moines, Iowa, and Detroit, unaware of what CALLAHAN mailed in them. Signed statement obtained. WEINHEIMER apparently called BAKER from Chicago, Illinois, at his hospital in Des Moines on 9/3/57. Phone bills of ESCO showed eight Des Moines calls in 8/57 and five Detroit calls in 9/57. Florida calls in 9 and 10/57 noted. WEINHEIMER's signature on one of the five registered mail receipts of pertinence hereto identified by FBI Laboratory as being written by him. No definite conclusion reached on remaining receipts. Additional signatures of WEINHEIMER being obtained for further comparison. e

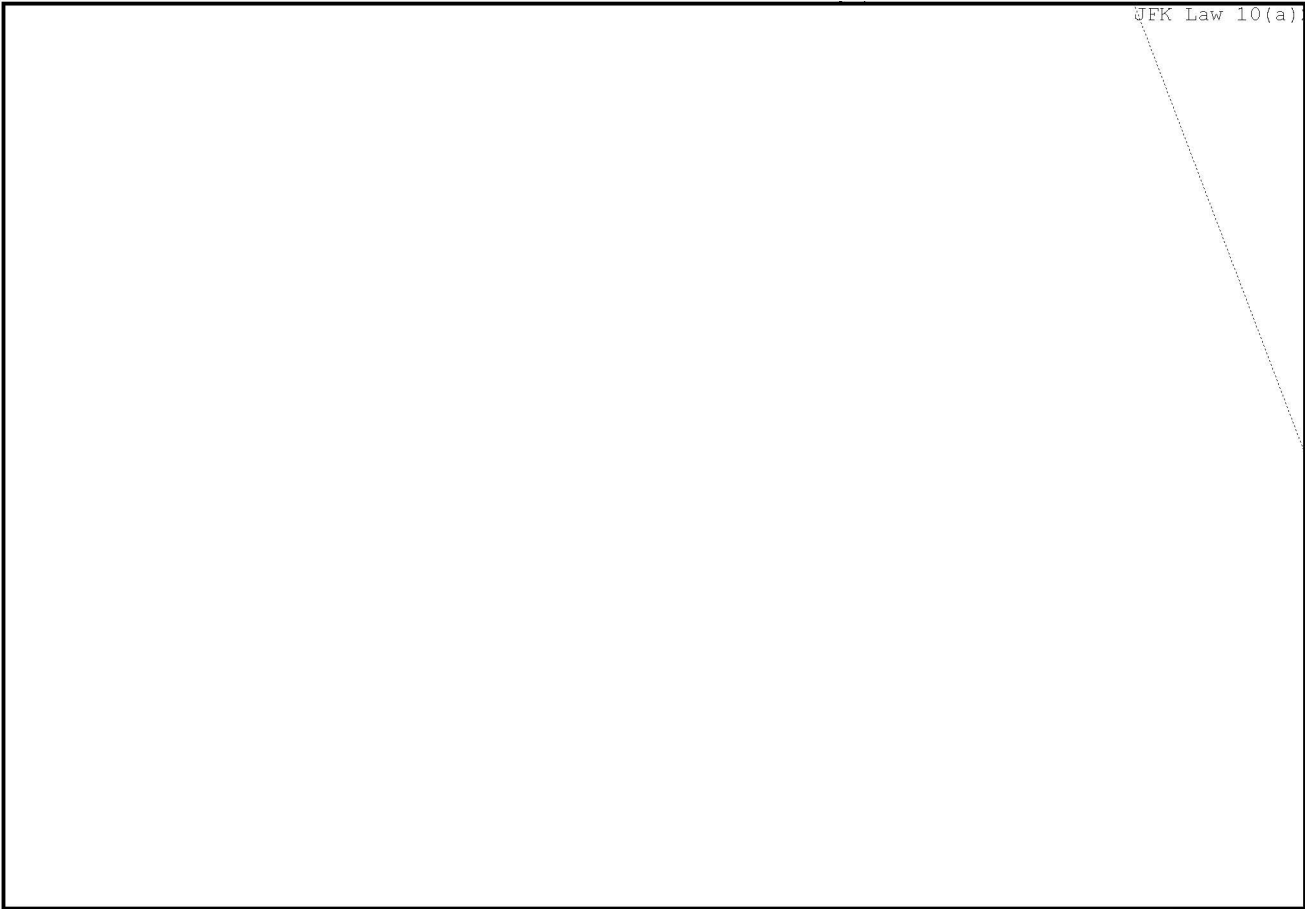

It is to be noted that a review of ESCO's telephone bill for October, 1957, as made available by FRANK LACEY, Assistant Secretary of ESCO, disclosed no traffic between ESCO and eastern points which would have been logical cities for WEINHEIMER to have been located in.
