On September 29, 1959, SA EDWARD W. PENNYPACKER obtained from Attorney PLATO CACHERIS, Department of Justice, two motel registration cards from Rambler Motel, Des Moines, Iowa, dated August 23, and 30, 1957, both bearing signature Mr. and Mrs. E. F. WEINHEIMER and six ESCO checks endorsed by WEINHEIMER. These documents were forwarded to the FBI Laboratory on September 30, 1959.
