Mr. CISNEROS stated he listened to the recording but he did not know what significance it might have since he could not understand it and therefore he desired to turn it over to the FBI as possibly being a coded message by anti-CASTRO elements. He said it would appear, or at least be his guess that the radio transmission was being sent from the area of Boston, probably directed to Cuba. Mr. CISNEROS stated ALDO GIL at Littleton, Massachusetts could furnish further details and also the name of the JURE member in the Boston area who monitored and recorded the transmission. CISNEROS added he understands that other transmissions of a similar nature have also been recorded by the member of JURE at Boston. He said the JURE delegation at Boston also possesses an identical copy of the tape recording which CISNEROS turned over to FBI, Miami. *u*

The tape recording furnished by CISNEROS is transmitted herewith to the Bureau with the suggestion it be furnished to for appropriate study. *(S)*
