football parlay cards; that he had found no evidence of a widespread distribution of such cards by any Denver bookmakers, but had established that one AL OVARASCI, operator of a small grocery market at 42nd and Pecos Street, had been distributing football parlay cards among petty gamblers in the North Denver area for \$1 each. He stated that he had found no evidence that GUARASCI has the backing of any well-known gamblers or bookmakers in the Denver area in this undertaking.

During the summer horse racing season at Centennial Race Track, north of Littleton, Colorado, DN 110-C reported that he was in close touch with activities at this track and that he found no evidence of any large-scale bookmaking activities being carried on there.
