ADMINISTRATIVE

According to Strike Force Attorney MICHAEL KING, Chicago, Illinois, a Federal Grand Jury hearing will be held at [redacted] concerning [redacted] and [redacted] inasmuch as [redacted] was one of the five individuals who was engaged in the gambling activities of [redacted] and who was afforded Title III coverage during September and October, 1971. In this regard, Strike Force Attorney requested that he be provided with a chronology of activities and events of [redacted] during the past several years which would aid in the Grand Jury investigation concerning this case and to provide a greater insight into [redacted] and his gambling associates. The details of this chronology is being set out in the details of this report for the additional information of the Bureau. Sources of information and investigative techniques used to acquire information have been protected and are being referred to only as "source".

On 7/14/72, CG 6187-C advised SA ROBERT L. MALONE that the Black Angus Restaurant was a hangout for Chicago area bookmakers belonging to the ~~LENNY PATRICK~~ group and that the restaurant was recently sold to ~~CHRIS CARSON~~ for \$250.00. Source added that the real owners of the restaurant were LENNY PATRICK and ~~DAVE YARAS~~ although it was titled under the son of YARAS. Source added that KLOTZ and ~~LOU HOPPER~~ were in Las Vegas, Nevada, recently to get more money to finance their bookmaking activities during the next football season.

On 10/2/72, CG 7386-C-TE advised SA JAMES D. DEWHIRST that KLOTZ was still betting and continued to associate with his old cronies and meet at the Cavendish Bridge Club, 22 West Madison, Chicago. Source stated that KLOTZ will go to extreme measures of caution in order to circumvent the Illegal Gambling Business Statutes and that KLOTZ apparently is now well aware of the details of the Federal gambling statutes.

On 8/24/72, CG 7434-PC advised SA LEE M. FARMER that KLOTZ hangs out at the Cavendish Bridge Club and is presently organizing his gambling activities for the fall football season. Source described KLOTZ as a compulsive gambler and bookmaker.

On 8/23/72, CG 7604-C advised SA JOHN E. OSBORNE that ANTHONY TITO and KLOTZ arrive at the Cavendish Bridge Club between 1:00 PM and 2:00 PM on Saturdays and Sundays and remain there until approximately 5:00 PM. Source added that KLOTZ was in the Las Vegas area recently for a period of three weeks in order to make connections for limited gambling business. Source added that NORMAN LA PORT, who comes from California, is a friend of KLOTZ.
