Information from bank records of The Liberty National Bank and Trust Company, Oklahoma City, Oklahoma, was obtained from Mr. KAY E. HOUSHOLDER, Assistant Cashier.

On 5/19/65, PCI JACQUELYN CHEWNING furnished information that during April, 1965, she learned LAWRENCE LEE GUINN was in Houston. The Houston Office is attempting to locate GUINN for interview concerning this matter. PCI's information was furnished to Houston by Dallas airtel, 5/27/65.

JACK MAYES, President, Greenville Avenue State Bank, was contacted by SA ROBERT M. BARRETT on 5/6/65.

By airtel 5/27/65, the Oklahoma City Office furnished Dallas with the results of extensive investigation conducted at Tulsa, Oklahoma, including interviews of a Tulsa banker, LYNN HELM, who had been taken in a dice game at the Marriott Hotel, Dallas, 4/26 - 27/65, by subject EDWARD VINCENT DRISCOLL and others. Investigation by Dallas has identified DRISCOLL's associates in this crap game as subject BILLY RAY GRIMES, EDDY TOM GREEN, and JERE BEDEORD JORDAN, a known Dallas area type hustler. A separate ITAR investigation of this matter is being instituted by Dallas by another communication. The FD 302's and inserts furnished in Oklahoma City airtel of 5/27/65, will be included in this separate ITAR investigation and will <sup>not</sup> be set out in any report submitted in instant matter.
