BROWNLEE advised that this was the only long distance telephone call which he has received from the State of Texas during the last ten years and he cannot in any way connect this telephone call with any of the individuals referred to above.

The following investigation was conducted by SA JOHN V. ALMON at Bristol, Texas:

A review of the telephone directory for the City of Bristol, Texas, on March 20, 1962, disclosed that telephone number MO 6-2131 is listed for R. C. THREADGILL, known in the community as "ROOSTER" THREADGILL. THREADGILL is well known in Ennis, Texas, as a gambler and close associate of JOHN HORRELL, Ennis, who has previously admitted in interview with Agents of the Dallas Office that he is a "bookmaker". THREADGILL has been arrested by the Ellis County Sheriff's Office on charges of gambling.

On March 23, 1962, the El Paso Office furnished the following:

The following investigation was conducted by SA THOMAS B. WHITE, JR., at the Federal Correctional Institution, La Tuna, Texas, on March 5, 1962:

JACK A. COHN, Record Clerk, advised that his records reflected that ALBERT MEADOWS had been incarcerated in that institution as Inmate No. 11511.

He made available the prison file pertaining to MEADOWS and a review of same reflects that he had FBI No. 856 929. For violation of the Federal Narcotics Laws, he was sentenced to serve two years by the United States District Court at Dallas, Texas, on March 1, 1939. He was arrested on this charge December 10, 1938, and was committed to the United States Penitentiary at Leavenworth, Kansas, on March 7, 1939, to serve this sentence. He was transferred to the Federal Correctional Institution at La Tune on May 6, 1939, and was released from this institution on October 7, 1940.

The file reflects that his wife is listed as Mrs. BEATRICE MEADOWS, 1413 St. Louis Street, Dallas, Texas.
