## DETAILS:

By letter dated November 6, 1972, the Intelligence Division, Chicago Police Department, furnished the results of a police surveillance of a Wedding Anniversary Party for GEORGE COLUCCI held at Sorini's Restaurant located at First Avenue and 26th Street, North Riverside, Illinois. Numerous cars registered to or driven by prominent Chicago hoodlums were observed at this affair. Included in the vehicles observed was a 1972 Dodge with 1972 Illinois License 561 397, registered to JOSEPH LOMBARDO, 2210 West Ohio Street, Chicago, Illinois.

T-1 in November of 1972, advised that the Golden Cleaver Restaurant which was located on Manheim Road and Franklin Park in 1969, was frequented by Chicago hoodlums including ANTHONY SPILOTRO, FRANKIE SCHWEIZ, TOM BLANDO, DOMINIC BLANDO, FRANK CALABRESE, CARMEN BASTONE and JOE LOMBARDO.

T-3 in October of 1972, advised that the subject frequents the American Bonding Company which is owned and operated by IRWIN WEINER on South State Street on a daily basis. The Fiber Glass business in Elk Grove Village is being operated by DANIEL SIEFERT, TONY BIANCO and BONNIE LEHMAN, also known as BONNIE VENT, the girlfriend of LOMBARDO.

On October 19, 1972, a visit was made at the Fiber Glass Company in Elk Grove Village, and it was determined at that time that LOMBARDO was not on the premises. The persons present on the premises at that time were DAN SIEFERT, and BONNIE LEHMAN.

In December of 1972, T-3 advised that the Internal Revenue Service had reviewed the books of the Fiber Glass Company.

JFK Law 11(a)

At 5:30 a.m., February 9, 1973, the building at 350 Bennett. Elk Grove Village, the premises of the Fiber Glass Company business operated by the subject, was gutted by a fire.

On February 13, 1973, Sergeant MC CARTHY, Intelligence Division, Chicago Police Department, advised that at approximately 8:00 a.m. Friday morning, February 9, 1973, JOSEPH LOMBARDO appeared at the scene of the fire and requested that he by allowed to retrieve company records which may have survived the fire. LOMBARDO was not allowed to retrieve anything from the building, and was not allowed to enter the burned out premises.
