## ADMINISTRATIVE

Referenced Dallas letter to Bureau advised that the Dallas Division, in accordance with Bureau suggestion, was closing the Armed Robbery investigation in the Dallas Division on RUSSELL DOUGLAS MATTHEWS and was reopening the ITAR - GAMBLING matter, which should be directed toward development of a substantive violation.

On 8/12/64, DL 208-PC advised that the gamblers in Dallas, Texas, were all commenting on the fact that MATTHEWS had not been seen or heard of around Dallas during the past two or three weeks. According to the informant, no one seemed to know where MATTHEWS was or what he was doing.
