ADMINISTRATIVE:

It is noted that the investigative period of this report overlaps that of the rerep, however this report includes investigation which was not available from an auxiliary office at the time the rerep was dictated.

On 11/16/65, DL 275-C-TE advised that MATTHEWS has not been in his place of business since approximately the first part of October, 1965 and that he, the informant, has not received any information as to where MATTHEWS is presently residing. He advised that in conversation with other bookmakers and gamblers, they have indicated that MATTHEWS has been inactive in the Dallas area and is occasionally observed playing cards at one of the private clubs.

He advised the last time he talked to MATTHEWS, MATTHEWS indicated he could not understand why the FBI was following him around and that he has not been active for approximately the last two years. Informant stated he did not explain what he mean't by this statement but informant is of the opinion he is talking about bookmaking, gambling, and associating with known hoodlums.

The following informants residing in the Dallas area have been contacted within the past month and all advised that they have no information to indicate that MATTHEWS is active in gambling or bookmaking in the Dallas area:

EP583C, who is familiar with gambling activities in the Midland area, stated that BILL J. SARGENT, Aka Billie Joe Sargent, is not known to him. EP583C stated if SARGENT is active in the gambling activities in this area, it would be known to him.
