for its main file 166-117 on RUSSELL DOUGLAS MATTHEWS and its file 166-1785, captioned as the last listed reference above. R. D. MATHEWS in all likelihood is identical to Dallas origin case on MATTHEWS, subject of this report, and who is currently running a bookmaking operation in Dallas.

For additional information of Oklahoma City, which will be reported separately under your case on JOHN DAYTON RITTER, DL 275-C-TE has advised that he has known RITTER for many years as a bookie and that RITTER had stopped by CI's place of business recently on return from New Orleans to Oklahoma City. CI states that RITTER and GEORGE BARNES, gambler, known to your office, are close friends, and as Oklahoma City is aware MATTHEWS and GEORGE BARNES are also acquainted and have been known through prior investigation to call each other. CI says that BARNES has returned to Oklahoma City, having given up his operation in Reno, Nevada.

DALLAS

AT DALLAS, TEXAS. (1) Will consider requesting Bureau authority to review telephone records on other telephones available to MATTHEWS, as according to recent information received by Dallas, subject is apparently furnishing betting line to out-of-state bookies, possibly one in Oklahoma. This aspect is involved in separate case, Oklahoma City origin.

(2) Will continue to check subjects bookmaking location and will maintain contact with the Special Service Bureau, Dallas PD, re local charges pending against GEBRON.

(3) Will follow and report results of leads set out separately to determine the subscribers and background of calls made from subjects telephones in Garland as set forth in details of this report.

AT GARLAND, TEXAS. Will follow local prosecution of subjects.
