records, Lubbock, Texas, on 7/17/69, was furnished by ROBERT L. METTS, Security Supervisor.

Information concerning telephone number 377-3105, Frisco, Texas, and reported herein in FD-302 form was obtained from MRS. AVO CLICK, Southwestern Bell Telephone Company, McKinney, Texas.

Information concerning telephone subscribers in the Los Angeles Office was furnished by CS LA 4178-S, a representative of the Pacific Telephone and Telegraph Company, who furnished information to SA BURL P. MIDDENDORF on 6/13/69.

Information furnished from the Southern Bell Telephone Company at Atlanta, Georgia, to IC MARION W. DAVIS on 6/17/69, was made available by MRS. BETTY HAYES.

On 7/17/69, DL 146-C advised SA JAMES W. BOOKHOUT that ~~RYDE~~ MATTHEWS had recently had an operation removing a bad eye and having an artificial eye to replace it. He reported that MATTHEWS had been frequently seen at Lake Dallas in the company of GARLAND POLLARD and GLEN BECKER. POLLARD is a well known bookie in the Dallas area. MATTHEWS has been keeping company with a woman named HELEN FITZ WILLIAM who has a boat which she keeps at the Hundley Boat Dock at Lake Dallas. This informant also advised on 6/25/69, that MATTHEWS claims that CHARMAYNE VOURAS allegedly has put out a contract on him and has offered someone \$25,000 to kill him.

DL 275-C-TE advised SA WILLIAM B. HOLLOMAN on 7/10/69, that MATTHEWS and SOPHIE GEBRON are still booking together in the Dallas area. He stated that MATTHEWS is not associating with STANLEY COOK at the present time because of COOK's association with CHARMAYNE VOURAS. COOK in the past had been used by MATTHEWS and GEORGE MCGANN as a muscle man. Informant stated that MATTHEWS has tried to warn COOK that VOURAS is dangerous but even though he has learned that she carries a gun in her purse he is still living with her. CI claimed that MATTHEWS recently told him that CHARMAYNE VOURAS had been shot by him accidentally when he went to her residence after meeting her at a club. He claimed that she pulled a gun on him and told him that she had heard that he had a contract to kill her. MATTHEWS allegedly struggled with VOURAS for the gun and it accidentally went off, wounding her. He then took her to a local hospital
