#### ADMINISTRATIVE:

Two symbol numbers have been used to further conceal the identity of NO 1283-C-TE, whose identity is known to the Bureau.

Inasmuch as the subject of this case is being contacted under the TECIP, this case is being placed in a pending inactive status.

Information relating to telephone toll records is not being set forth in this report inasmuch as this investigation has failed to disclose any pertinent information.

The following is being set forth in the administrative section due to the singular nature of the information:

NO 1283-C-TE furnished the following information to SA HAROLD V. HUGHES on 4/16/74:

Source advised that NOFIO PECORA, JR., son of the well-known New Orleans hoodlum, NOFIO PECORA, is going in business with the Orleans Parish Coroner, Dr. FRANK MINYARD, in the purchase of a 400-acre farm at McNeil, Mississippi. This farm will be used for raising cattle and was formerly owned by the late Senator A. D. SMITH, brother of FRANCES PECORA.

This farm is being purchased for \$125,000 and a Government loan is being obtained so that the total cash outlay on the part of young PECORA and Dr. MINYARD will only be \$10,000 or \$20,000.

Source said this extremely favorable price was obtained from the bonding company which has taken over all of the assets of the late Senator A. D. SMITH because of FRANCES PECORA's relationship with SMITH and because of her position of influence in the State of Louisiana, with the State Insurance Board.

Source pointed out that the house alone on the property is valued at somewhere around \$75,000.00. Source said that he believed that realistic evaluation of the property would be somewhere in the neighborhood of \$300,000.
