BA 1267-C advised on May 14, 1964, that ALLEN CHARLES FISHER, principal involved in the arrest by Maryland State Police at the Charlotte Hall gambling club in June, 1963, currently employed as a gambler in the El Cortez Hotel which was reportedly located to be in either Las Vegas or Reno, Nevada. CI indicated that she has determined that FISHER is definitely in either Reno or Las Vegas. However, she could not guarantee that it was definitely the El Cortez Hotel that he is employed in.

LEADS:

LAS VEGAS DIVISION

AT LAS VEGAS, NEVADA

Determine location of El Cortez Hotel, determining thereafter if ALLEN CHARLES FISHER is so employed. In the event hotel is non existent or if not so employed, contact appropriate sources in an effort to determine where in Las Vegas or Reno FISHER is currently located. No interview of FISHER should be conducted at this time concerning this matter.

RICHMOND DIVISION

AT KING GEORGE COUNTY, VIRGINIA

Locate and interview EDWARD HAMWAY who reportedly resides in a pink split level house on Route 3, one mile from the intersection of Route 3 and Route 206 near Fredericksburg, Virginia. For Richmond's information, HAMWAY was associated with C. MILES MATTINGLY of Leonardtown, Maryland, during June, 1963, when both individuals leased the Sportsman's Club Restaurant from PHILIP E. GRAY of Lexington Park, Maryland. HAMWAY reportedly negotiated with ALLEN CHARLES FISHER in permitting the shack behind the restaurant to be renovated which ultimately was used by the principals, NESLINE, TOURINE and FISHER in the gambling club, which club was raided by Maryland State Police on the
