PG T-8 is [REDACTED], a professional Pittsburgh bondsman and a former PCI of the Pittsburgh Office, who was contacted by SA JOHN S. HUGHES on 9/14/51.

PG T-9 is JAMES O'CONNOR, former Chief Identification Officer of the Pittsburgh Police Department, who was contacted by SA JOHN S. HUGHES during 1951.

PG T-10 is JOHN DEVLIN, former Allegheny County Deputy Sheriff, who was contacted by SA JOHN S. HUGHES during 1952.
