ReBulet 12/6/62, entitled "Fair Play for Cuba Committee; Registration Act - Cuba," which set forth information regarding subject's plans to visit countries in North Africa.

Bureau Source <sup>(S)</sup> [redacted] has furnished information indicating that one Loeches [redacted] was in contact with the [redacted] Cuba on 12/14/62. At that time, Loeches indicated that the subject had requested that his salary be forwarded in the future to the revolutionary newspaper in Algeria in the name of the Directors of that paper. The source explained that the newspaper involved was probably "El Kudjevid," which is an Algerian weekly newspaper. ~~(S)~~
