WELFARE/WHEREABOUTS: RICHARD THOMAS GIBSON, BORN LOS ANGELES, MAY 1931, REPORTED TO BE JOURNALIST REPRESENTING NEGRO PRESS INTERNATIONAL, CHICAGO AND ACCREDITED UN NEW YORK, TRAVELING BY TRAIN FROM MILAN TO GENEVA WITH BRITISH WIFE, JOY GIBSON, WAS REMOVED FROM TRAIN BY SWISS IMMIGRATION AUTHORITIES BRIG SATURDAY JANUARY 20 AND DENIED ENTRY SWITZERLAND.

2. MRS. GIBSON SPOKE TO EMBASSY DUTY OFFICER BY TELEPHONE FROM BRIG AND REQUESTED DIRECT INTERVENTION WITH SWISS AUTHORITIES.

MAGAZINE "LA REVOLUTION AFRICAINE". ON DECEMBER 16, 1963 THE BUNDESANWALTSCHAFT (FED. POLICE & JUSTICE DEPT.) ISSUED ORDER PROHIBITING GIBSON'S RE-ENTRY SWITZERLAND, BUT AS WHEREABOUTS UNKNOWN, NOTIFICATION COULD NOT BE SENT HIM. FFP OFFICER STATED THAT IF GIBSON HAD APPLIED ENTRY SWITZERLAND DURING WEEK INSTEAD WEEKEND, MAY HAVE BEEN AUTHORIZED LIMITED ENTRY. ACCORDING FFP OFFICER, GIBSON SHOULD WRITE BUNDESANWALTSCHAFT, 3003 BERN CONCERNING INCIDENT AT BRIG AND REQUEST HE BE INFORMED REASON. HE WILL THEN RECEIVE COPY OF THEIR ORDER AND WILL HAVE OPPORTUNITY APPEAL DECISION WITHIN 30 DAYS.
