The Pennsylvania State Police report reflected that the cost of these rooms and all attending charges were billed to BUFALINO.

Lieutenant HARVEY W. TOTTEN, Dallas Police Department, advised SA VINCENT E. DRAIN on February 9, 1958, that a Sergeant REYNOLDS of the New York State Police and JOHN MC KEON of the Westchester County District Attorney's Office, contacted TOTTEN on February 9, 1958. They advised TOTTEN they had surveilled JOSERH FRANCIS CIVELLO and his wife from New York to Dallas, Texas, and that the subject had just arrived in Dallas via the Texas and Pacific Railroad.
