CN MAY-19: 1977, AN OPERATIONAL ASSET (OA) MET WITH CUBAN INTELLIGENCE SERVICE (CUIS) CONTACTS AT THE XOLA METRO STATION IN MEXICO CITY, MEXICO. HE WAS TAKEN IN APRENTED AUTOMOBILE FROM THAT LOCATION TO THE SAN MIGUEL HOTEL IN PUEBLA CITY. THAT LOCATION, HE WAS CONFRONTED WITH A TELEVISION AND VIDEO TAPE TECHNICIAN WHO, HAD SET UP A VIDEO TAPE MACHINE AND A MICRO-PHICKE PREFORE WHICH THE DA WAS PLACED AND ASKED VARIOUS QUESTIONS. ON WAS TOLD THAT THIS TAPE WAS FOR THE BENEFIT OF HIGH LEADERS IN CLEAR INCLUDING FIDEL CASTRO. TOA WAS ASKED APOUT HIS FAMILY. SIJUATION IN CUBA BEFURE CASTRO TOOK CONTROL THERE. HE WAS ASKED ABOUT HIS HISTORY WITH ALPHA 66 AND HIS PART IN AN ATTEMPT TO ASS-ASSINATE FIDEL CASTRO IN CHILE IN 1971. HE WAS ADDITIONALLY ASKED ABOUT THE ASSASSINATION OF JOHN F. KENNEDY, ANTONIO VEGIANA, POSSIBLE CIA AGENTS WHO HAD WORKED IN THE UNITED STATES EMBASSY IN CUBA BURING THE BATISTA REGIME, AND HIS PART IN A 1961 PLOT IN HAVANA TO ASSASSINATE FIDEL CASTRO.

DURING THE ABOVE VIDEO TAPING, OA WAS ASKED TO SEND A MESSAGE TO FIDEL CASTRO VIA THAT TAPE. OA COMPLIED AND SPOKE OF CASTRO AND THE CURRENT CUBAN GOVERNMENT IN A FAVORABLE MANNER. O'N ALSO COMMENTED THAT HE WAS VERY PLEASED WITH THE CUIS AJENTS WITH WHICH HE HAS HAD CONTACT.

ONE OF THE CUIS AGENTS STATED THAT HE WOULD LIKE TO SEE
THE OA GO TO CUEA FOR THREE OR FOUR DAYS TRAINING. IT WAS
SUGGESTED THAT THE OA COULD POSSIBLY TRAVEL BY BOAT FROM
JAMAICA OR FLORIDA TO REACH CUPA. THE OA STATED THAT HE HAD
NO INTEREST IN TRAVELING BY THIS MANNER AND WAS NOT SURE AS TO
WHETHER HE WOULD BE WILLING TO GO TO CUBA. THE CUIS AGENT ADDED
THAT ONE OF THE PURPOSES OF HIS TRAVEL TO CUBA WOULD BE TO MEET.
FIDEL CASTRO AND OTHER CUBAN LEADERS. IT WAS ADDITIONALLY
SUGGESTED BY CUIS THAT THE OA TRAVEL TO FLORIDA AND SPEND
THREE OR FOUR DAYS MIXING WITH COORDINACION DE ORGANIZACIONES
REVOLUCIONARIAS UMIDAS (COORDINATION OF UNITED REVOLUTIONARY

IN KINGSTON, JAMAICA, ON AUGUST 11, 1977, OA WAS INSTRUCTED THAT IF HE SHOULD REED TO CONTACT THE CUIS, EITHER IN MEXICO CITY OR JAMAICA, HE COULD SEND A CABLE TO EITHER JUAN CARBONELL, NO. 9 TRAFALGAS AVENUE, NEW KINGSTON, JAMAICA, OR TO PEDRO CAMPO, NO. 554, PRESIDENTE MAZARIK, COLONIA POLANCO, MEXICO, 5, D.F., AND STATE THAT ON A CERTAIN DATE HE WAS GOING TO PICK UP A VISA FOR DR. MIRANDO PRADO, AND ACTUALLY REPORT TO THE DESTINATION THREE DAYS EARLIER THAN THE DATE MENTIONED IN THE CABLE.

OF THE CUIS AT THE VACA NEGRA PESTAURANT WHICH IS LOCATED NEAR UNIVERSIDAD AND PILARESISTREET, MEXICO CITY, MEXICO, AND ACCORDING TO THE DA. NOT A LARGE DISTANCE FROM THE DIPLOMATICO HOTEL OR THE COMERCIAL MEXICANA SHUPPING CENTER.

GA MENTIONED THAT PRIOR TO TRAVELING TO MEXICO CITY, HE SPENT SEVERAL FOURS WITH ANTONIC VECTANA IN MIAMI, FLORIDA, WHO HAD BEEN PRIVY TO BARDIER CONTACTS BETWEEN OA AND CUIS. VECIANA TOLD THE DA TO ADVISE HIS CUBAN GOVERNMENT CONTACTS #THAT OREANDO BUSCH RECENTLY INSTRUCTED CORU TO PLANT A BOMB IN NEWE BUBLA MHICH MOULD CAUSE VERY LITTLE DAMAGE. DA WAS TO FURTHER ADVISE THAT IF BOSCH DID NOT GET A SPEEDY TRIAL IN VENEZUELA; CORU WOULD AGAIN PLACE A BOMB WHICH WOULD CAUSE CONSIDERABLE DAMAGE TO SOME VENEZUELAN PROPERTY. VECLANA ADVISED DA TO TELL THE CUBAN GOVERNMENT OFFICIALS THAT (FNU) ALDEREGUIA, A RESIDENT OF MIAMI, FLORIDA, AND WHO HAD BEEN EARLIER RUMORED TO BE WORKING FOR THE FIDEL CASTRO GOVERNMENT, WAS CURRENTLY WORKING FOR THE PANAMANIAN INTELLIGENCE SERVICE. VECIANA ALSO REQUESTED THAT THE CA ADVISE THE QUBAR OFFICIALS THAT CORU RECEIVES MONEY FROM THE "LITTLE HAVANA" WELFARE OFFICE IN MIAMI, FLORIDA, VECIANA STATED THAT RAFAEL VILLA VERDE IS CURRENTLY IN CHARGE OF THAT OFFICE,

CUIS CONTACTS IN MEXICO CITY TOLD OA THAT PREMIER CASTRO HAS FORTHCOMING NEWS INTERVIEW WITH UNNAMED U.S. TV NETWORK DURING NEXT TWO WEEKS, AND THAT CUIS MANTED HIM TO SEE THE VIDIO TAPE PRIOR TO THIS INTERVIEW. OA WAS ASSURED THAT THIS TAPE WOULD NOT BE GIVEN ANY PUBLICITY WOUT WAS FOR PREMIER CASTRO'S PERSONAL USE. HOWEVER, THE NATURE OF THE QUESTIONS INDICATES THE ROSSIBILITY.
