Mrs. ROBERT BALDWIN. By letter, 6/26/60, Miami advised that
according to CIA, ABASCAL was on the Propaganda and Public
Relations Committee of the FRD and was authorized to contact
influential people to seek support of the FRD.

No further investigation is being conducted in this
matter and this case is being placed in a closed status.
