On July 1, 1963, United States Customs Agents confiscated a 23' Seabird blue fibreglass boat belonging to BATISTA. The boat contained Florida registration #FL 1218F and was confiscated because it carried a gun mount.

On July 19, 1963, Mr. WALLACE SHANLEY, United States Customs Agent, Miami, advised BATISTA appeared at the office of United States Customs, Miami, subsequent to the confiscation of the boat, for the purpose of having it released.
