PETITIONS FILED ON BEHALF OF SUBJECT WITH MEXICAN IMMIGRATION. IT HAD BEEN REPORTED THAT THESE WERE FILED BY THE ATTORNEY JORGE CASTILLO BUT HIS IDENTITY DOES NOT APPEAR ON THESE DOCUMENTS. (S)(u)

ABOVE QUOTED SOURCE ADVISED THAT A NUMBER OF OFFICIALS OF MEXICAN IMMIGRATION ARE AWARE THAT CASTILLO WAS THE ATTORNEY FOR THE SUBJECT. HOWEVER, HE DOUBTED THAT ANY OF THESE OFFICERS WOULD BE PERMITTED TO TESTIFY AS TO THIS INFORMATION. (S)(u) HE NOTED THAT CASTILLO CAME TO THE OFFICES OF MEXICAN IMMIGRATION IN REPRESENTATION OF THE SUBJECT AT THE TIME OF HIS DEPORTATION. (S)(u)

SUBJECT'S IMMIGRATION FILE IS RESTRICTED BUT SOURCE IS ATTEMPTING TO REVIEW IT TO DETERMINE IF CASTILLO APPEARS ANYWHERE THEREIN AS ATTORNEY OF RECORD. (S)(u)
