Re Bureau nitel to all SACs, 6/13/75.

The Bureau has advised that the code name "Houstudy 75" has been designated for all matters relating to House Select Committee To Study Governmental Operations with respect to intelligence activities, and the Bureau's handling of matters pertaining thereto. Use Bureau file 62-116464, and above caption for matters relating to House Committee as separate from Senstudy 75, for matters relating to the Senate Committee.

You will recall that the FBI has pledged full cooperation with these committees, however, we have an obligation that sensitive sources and methods are fully protected. If contacted by any member of this committee, you are to call attention to this matter to the SAC, who will contact Legal Counsel for guidance.
