 SELECT COMMITTEE (SSC)**

Reference is made to HSC letter dated July 22, 1975, requesting that the HSC be furnished with copies of all documents and materials provided by the FBI to the SSC. Pursuant to an agreement reached August 19, 1975, by representatives of the FBI, the Department of Justice and the HSC, all such material is being made available to HSC Staff Members for review at FBI Headquarters, and copies of material so designated by reviewing HSC Staff Members will be processed for delivery to the HSC.

On August 22, 1975, upon completion of a partial review of FBI material furnished the SSC, Richard Vermiere, HSC Staff Member, requested the HSC be furnished with documents previously given to SSC as they relate to:
 I - legal authority for FBI to (a) conduct investigations of internal security matters (b) collect intelligence information (c) engage in counterintelligence activities;
 II - jurisdictional agreements by the FBI and other Federal agencies in matters affecting above three cited areas;
 III - FBI organizational chart at Headquarters level; and
 IV - policies and procedures followed by the FBI concerning investigations conducted in above three cited areas along with copies of stipulated sections of the FBI's Manual of Instructions and Manual of Rules and Regulations.
