DR. MARTIN LUTHER KING, JR., OF THE SOUTHERN CHRISTIAN LEADERSHIP CONFERENCE (SCLC) SUBMITTED PURSUANT TO REFERENCED COMMUNICATIONS UP TO AND INCLUDING DECEMBER 31, 1968, BE PREPARED FOR DELIVERY.

THE HSCA REQUESTED THAT OUR RESPONSE IN THIS MATTER BE GIVEN TOP PRIORITY OVER ALL OTHER ASPECTS OF KING INVESTIGATION.

On 6/12/78, Richard Bushing, Supervisor, FBI Headquarters, phone ext 3685 phoned and advised he had a new request from the House Committee. Their request was directed at one William M. Roy, born 7/15/39. Roy was apparently a suspect in the Piper case and there are several references to Roy in Bureau indices. Bushing asks that types check indices re Roy and provide pertinent information. The attached represents private references to Roy. It is requested that this case be reopened and these references be reviewed. It is requested that photos be obtained from the files and the references be written up in a correlation memo. References - eels 302 interviews, etc can be xeroxed.

THE PAGES WHERE RAY IS MENTIONED AND ENOUGH ADDITIONAL INFORMATION TO LOGICALLY UNDERSTAND WHY THE INVESTIGATION CONCERNING RAY WAS CONDUCTED. FOR EXAMPLE, WHERE RAY IS LISTED AS A REFERENCE IN A VOLUMINOUS PINAP (MINNEAPOLIS FILE 7-567) REPORT ON ONLY THREE PAGES, THEN ONLY COVER PAGE AND A COPY OF THE SYNOPSIS OR TABLE OF CONTENTS PLUS THE THREE PAGES PERTAINING TO RAY WOULD HAVE TO BE SENT.

ALL MATERIAL SHOULD BE FORWARDED BY COVER LETTER TO FBIHQ, ATTENTION: CONGRESSIONAL INQUIRY UNIT, RECORDS MANAGEMENT DIVISION, BY JUNE 19, 1978.

Enclosed herewith for the Bureau are 2 Xerox copies of pertinent serials in two packets located in the Minneapolis Division pertaining to WILLIAM H. RAY, born July 15, 1939. Also enclosed are two photos of RAY.

For the information of the Bureau, there are no main case files on RAY. All references to RAY were located in the PINAP file of Minneapolis which pertains to the kidnapping of Mrs. VIRGINIA PIPER in 1972. The references generally relate to RAY and are contained in serials wherein he was afforded a polygraph exam, and daily summary teletypes wherein the test was discussed and general serials where he is considered a possible suspect.

One reference to RAY was not in its file and one volume containing a particular serial was not located.
