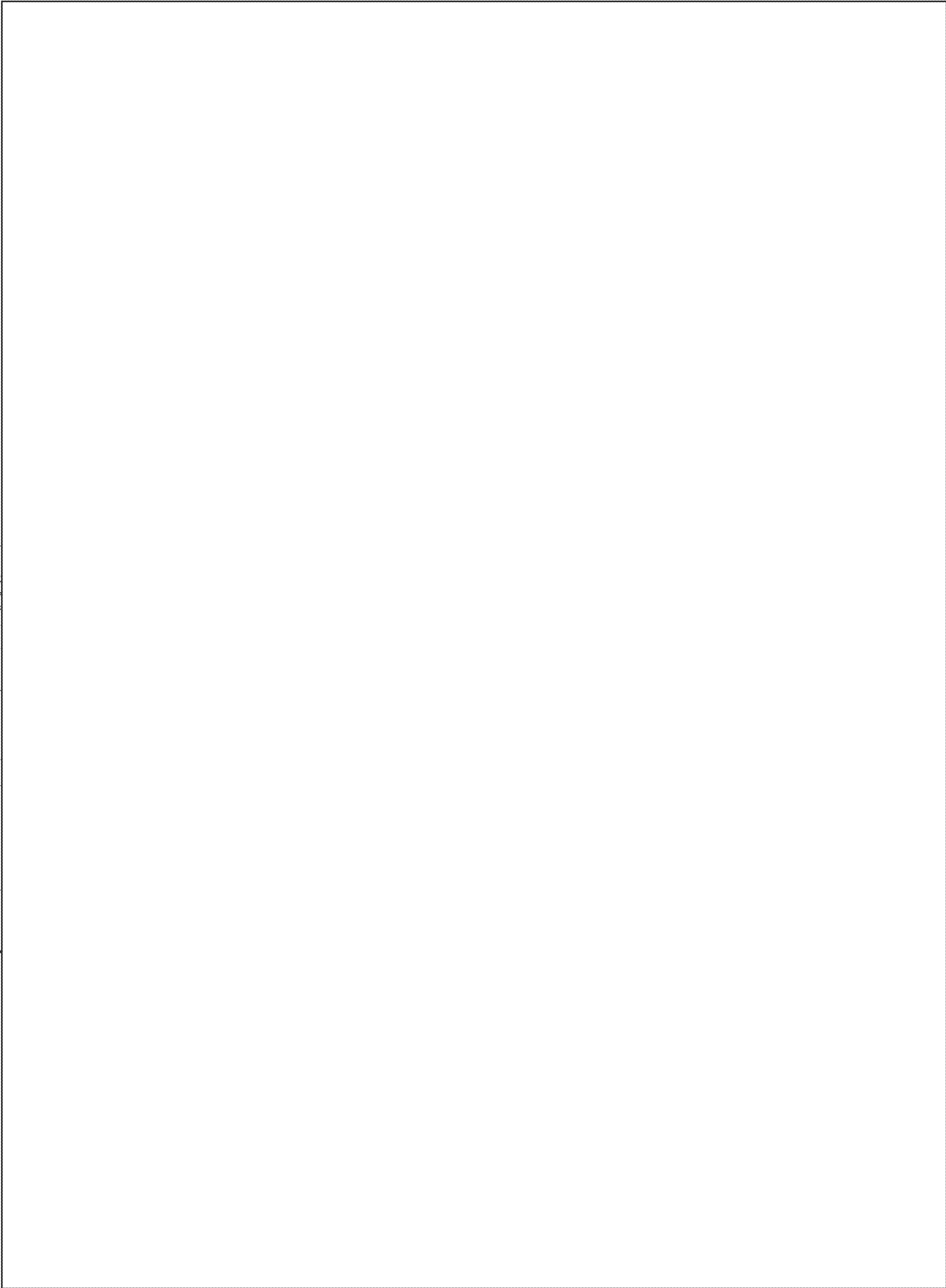

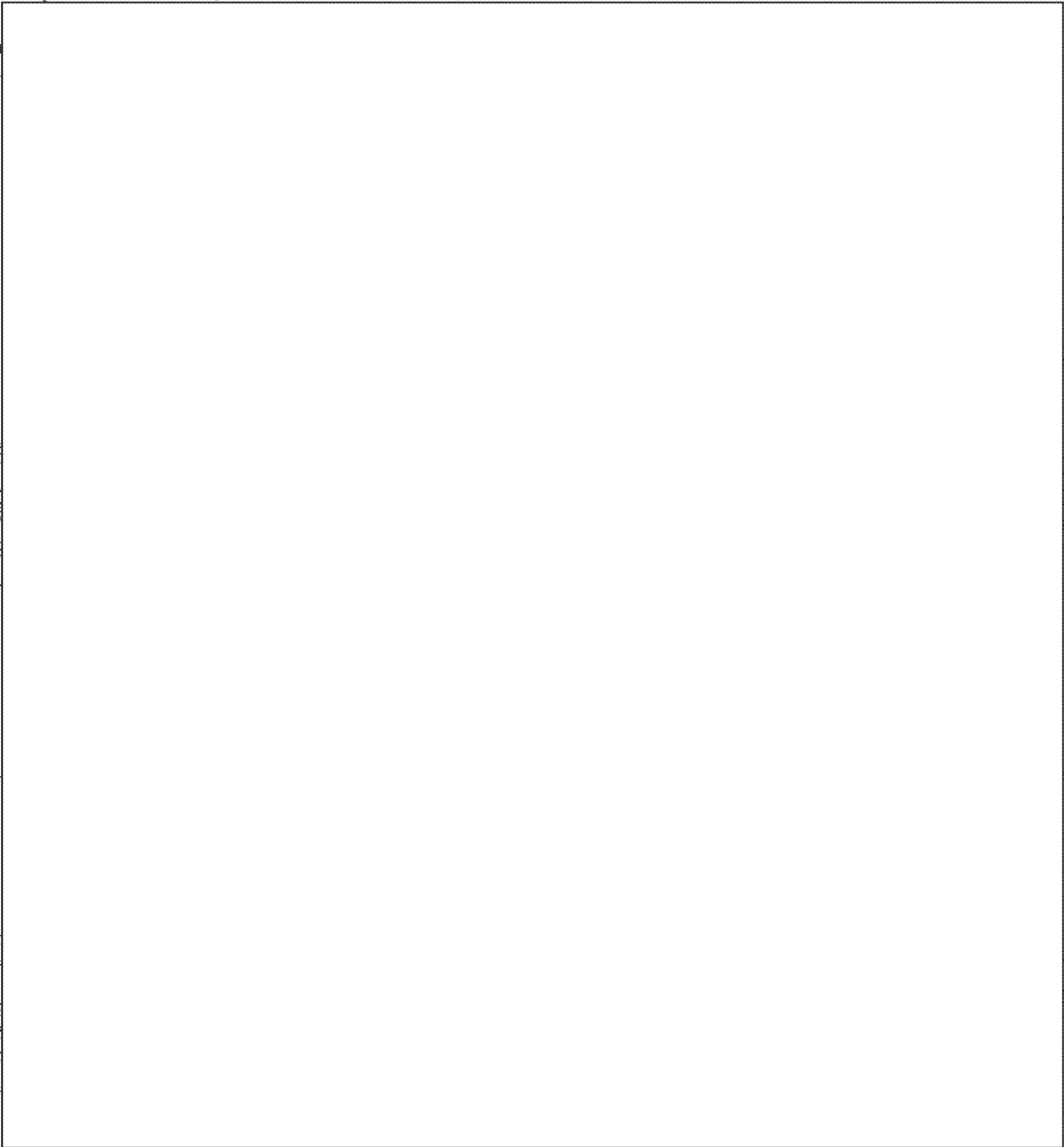

The meeting was held at the home of STRAND, and was attended by the American Communists Maurice HALPERIN and Noah SEBORER and possibly by other stockholders.

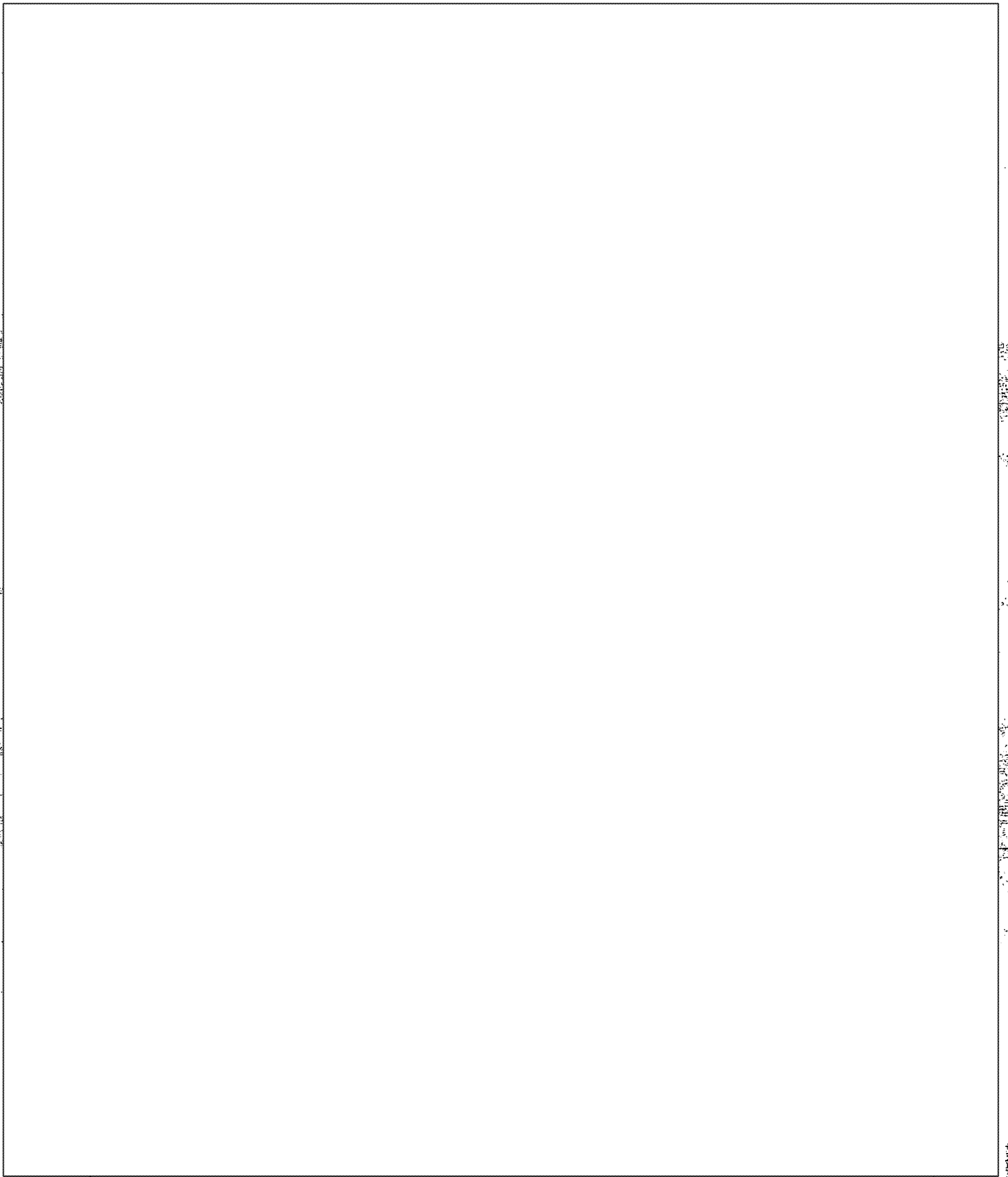

Maurice HALPERIN was dismissed from Boston University because of refusal to answer questions before a Congressional Committee. With him in Mexico are his son, David, his wife Edith and, at least during part of April, his or his wife's father, Noah SEBORER supplied Yiddish newspapers for the father to read. The HALPERIN'S dined at the SEBORERS 14 May 1955. HALPERIN is believed to be engaged in the trucking transportation business in connection with the firm E.A. QJeda at Isabel la Catolica 38-610.
