



1. Forwarded herewith are Summary Traces in SPK format on [redacted] (201-779495) who is suspect [redacted]. Paragraph 20 of the Summary is for passage [redacted].
2. Subject is not identical to [redacted] (201-121531). When Subject first arrived [redacted] in August 1962, he was reported as [redacted] and this error was not corrected until May 1965; therefore, two Checklists carried the wrong man PCS [redacted]. When the records were corrected, the Subject's birthdate was not, and the same date was listed for both parties. Headquarters records do not list a wife or other dependents for [redacted] and, as far as is known, he has not been assigned abroad PCS prior to the date of this dispatch.



10. PERSONALITY, CHARACTER, AND HABITS:

Although Subject acted as a guard [redacted] [redacted] he appeared to be fairly well educated and was not subservient to any of the other [redacted] with the exception of [redacted] (201-028975). On one occasion Subject was reported to be helping the daughter [redacted] [redacted] with her arithmetic homework. On another, Subject was asked about methods of producing metal wire, a subject on which Subject was well informed as a result of his having once worked for a wire factory.

Subject had a tape recorder at home which he liked to listen to. He also occasionally went fishing [redacted]

Subject told [redacted] to build a large garage, because he was bringing a big car back with him. He also asked whether [redacted] had bought a refrigerator and TV for the apartment. On another occasion he was negotiating for a can of paint to take back [redacted] with him to repaint [redacted]

1. Headquarters agrees that Subject is probably not identical with [redacted] (201-121531) as was earlier believed, and has accordingly assigned [redacted] 201-779495. A full Headquarters trace under that name turned up no information other than that originating from [redacted] Station, which has now been re-classified into the new file. We are puzzled by the fact that [redacted] 1850, dated 1 September 1962, the first piece of correspondence from [redacted] Station on Subject, reported him [redacted]

2. A photo comparison of the two individuals in this case is not satisfactory proof that they are in fact two people because of the difference in years and exposure in the photographs. The [redacted] traces on [redacted] reflect only a date and place of birth as identifying data. It is hoped that [redacted] Station can obtain soon identifying biographic data [redacted] in order to firmly resolve the matter.






