From a usually reliable, sensitive source, information has been received that a 1963 Oldsmobile, 4 door, grey and blue, carrying New Mexico license plates 6-11488, was parked in front of the Cuban Embassy in Mexico City on 6 November 1967. The license plates had red numbers on a yellow background.

2. A man, woman and child were seen leaving the Cuban Embassy and driving away in the Oldsmobile. It was later learned that the man gave his name as Luis SUAREZ, and he appeared to be Cuban. He was 1.60 meters, weighed about 60 kilos, was about 45 years old, had black hair, aquiline nose, and large face. The wife had dark hair and appeared to be mulatto. The child was about 3 years old. 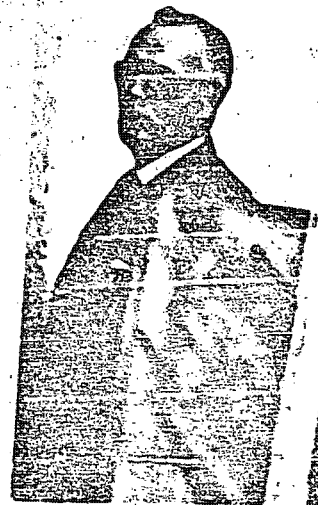

1. Kentucky license plate 763-944 was issued to David William PHILLIPS of 168 Franks Court, Harrodsburg, Kentucky, on 25 February 1966 for use on a 1959 Studebaker. His driver's license showed he was born 26 June 1920 in Mercer County, Kentucky. As of 1963 he was a city policeman. There were no Headquarters traces on PHILLIPS.

2. On 7 January 1967 the same license number was issued to Henry French WALLACE (201-349563), 7801 Rose Island Road, Prospect, Kentucky, for use on a 1964 Chrysler Imperial four-door hardtop. He had no police record and lists his occupation as a farmer. Headquarters traces follow:

a. RIRA-1023, 7 July 1952. Henry WALLACE, TIME representative in Tangier is the boy friend of Sonja de VRIES, who was then reportedly a young Dutch girl and member of the Dutch Youth Party. On an unspecified date she was to have attended the Youth Congress in Prague. Although she was not a card-carrying member of the CP, she is definitely a Communist and has admitted to it. She and her sister were at that time living in Tangier.

b. DBA-31569, 31 December 1962 is a rather voluminous study on Henry French WALLACE, who was born in Louisville, Kentucky, 12 June 1915 and at that time resided in the family estate rural area near Prospect, with his wife, the former Sonja de VRIES WALLACE and children. He is a former newsmen who spent several years as a free-lance correspondent in Cuba and has reportedly been a correspondent for LIFE and TIME. Reportedly formerly employed various papers in Lexington, Cincinnati, Puerto Rico, Dayton and the Department of

Agriculture and the FCC. Sonja's Communist affiliations, along with those of her family are set out in this study. WALLACE's father, the late Tom WALLACE, former editor of the LOUISVILLE TIMES and exponent of hemispheric solidarity, blamed the United States for poor Latin American relations. Henry WALLACE is a prolific writer of letters to public opinion columns of Louisville newspapers in support of the CASTRO regime in Cuba and critical of U.S. policy toward Cuba.

c. DBA-35720, 1 March 1963, reported Subject served in the U.S. Merchant Marine from November 1942 to February 1943 when he was discharged by reason of physical disability.

d. DBA-38513, 16 April 1963. A U.S. official in Cuba described WALLACE as an excellent writer, an exhibitionist and a very odd person. A correspondent for CHICAGO TRIBUNE believed WALLACE to be a Communist sympathizer or at least to have an affinity for Communists and fellow travelers as exhibited both by his actions and his writings. A TIMES correspondent who was acquainted with WALLACE for years, did not believe him to be a Communist but said he is restless, desires to be exceptional; however, appears to have no dedicated idealism.

e. DBA-44329, 17 June 1963. WALLACE graduated from the University of Kentucky in 1938. Worked for the Lexington Kentucky newspaper, 1938-40; Puerto Rico WORLD JOURNAL, 1940-41; Federal Communications Commission, Puerto Rico, 1942. Reportedly contributed to the Fair Play for Cuba Committee and received the WORKERS WORLD. WALLACE claimed he refused to permit his wife's cooperation with I&NS as a condition to her receiving citizenship.

f. DBA-49729, 23 August 1963. An LNERGO source who was previously assigned to the American Embassy, Havana advised that he knew Subject in Cuba 1947-51. In 1949 Subject was requested by the Cuban government to leave due to an article he wrote for LIFE about his carefree life with Cuban girls. Source described Subject's wife as a "beatnik". While the source was not aware of the political beliefs of Subject or his wife, he received a letter in mid-1963 from WALLACE which was very pro-CASTRO. The envelope contained a saying "Ban A-Bomb" or something of this nature.

g. DBA-98318, 4 February 1965, reported that WALLACE and his family were going to Holland for an extended visit and have reportedly applied for permanent residence in Holland. Mrs. WALLACE became a naturalized U.S. citizen on 30 August 1963. WALLACE contributed to the American Committee for the Protection of Foreign Born in 1963; in 1964 subscribed to PEKING REVIEW, and contributed to the National Committee to Abolish the House Un-American Activities Committee. Set forth in this report were associations with various American CP figures.

h. ONHA-33396, 23 December 1966. A reliable source reported that Soviet Intourist representative in The Hague, Vladilen Aleksandrovich PRYAKHIN (201-236430) in in contact with Klaas de VRIES, Dutch Communist and father of Sonja WALLACE (nee de VRIES). Klaas de VRIES, Dutch Communist, has made several trips to the USSR, is a financial supporter of the Communist Party of the Netherlands, and his restaurant is visited by various Iron Curtain diplomats, but also, however, by different Dutch Government officials.

3. The information contained in paragraphs 1 and 2a and h. have been made available to LNERGO Headquarters, along with photographs of the man and woman and a request that WCFAC be informed if either of the two individuals in the photos are positively identified. You will be notified if any further information is received from LNERGO on this case.

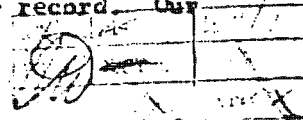

1. A reliable source reported that on 30 January 1967 a man and a woman driving a vehicle with Kentucky license plates 763-944 visited the Cuban Embassy in Mexico City. They left the Embassy carrying a bulky package. The windshield of their car carried a sign saying "Fuera de Vietnam." A set of photos showing the man and the woman are provided your Bureau for identification. This Office would appreciate being informed if either of the two individuals in the photos are positively identified.

2. Investigation revealed that Kentucky license plates 763-944 were not issued in 1965. On 23 February 1966 these plates were issued to David William PHILLIPS, 4166 Franks Court, Harrodsburg, Kentucky. PHILLIPS's Kentucky driver's license shows that he was born on 26 June 1920 in Mercer County. As of 1963 he was a city policeman and had no derogatory police record. The files of this Office show no record of PHILLIPS.

3. On 7 January 1967 the same license number was issued to Henry French WALLACE, 7801 Rose Island Road, Prospect, Kentucky. WALLACE's driver's license shows that he was born 12 June 1915 in Louisville, Kentucky. He lists his occupation as farmer, and has no police record. Our Office traces on WALLACE follow:

a. The visitor to the Cuban Embassy could possibly be Henry French WALLACE, Journalist, who is well known to your Bureau as a former resident of Cuba and an outspoken critic of U.S. policy on Cuba.

b. He is married to Sonja de VRIES, who, according to a usually reliable source, was in 1952, a member of the Dutch Youth Party and on an unspecified date was to have attended the Youth Congress in Prague.

c. A reliable source reported in December 1966 that a Soviet Intourist representative in The Hague was in contact with Klaas de VRIES, Dutch Communist and father of Sonja WALLACE (nee de VRIES). Mr. de VRIES has made several trips to the USSR and is a financial supporter of the Communist Party of The Netherlands.

On February 13, 1967, Daniel Boone, Salesman, Bill McNavid Oldsmobile, Inc., 1414 Milam, Houston, Texas, advised in February, 1966, he sold a 1966 Oldsmobile "98" sedan, luxury series, Vehicle Identification Number 30696M155453, to Hilda Hernandez who is a resident of Mexico. He advised the automobile was paid for in cash by Jesus Urrechaga at Chapultepec 230, Mexico 7, D. F.

Mr. Boone advised Urrechaga has been buying cars from the company since 1962 and he understands Urrechaga is in the steel business in Mexico and Hilda Hernandez is his wife or close relative. 1. A usually reliable source reported that on 5 December 1966 a Ford Mustang bearing Texas license plate GTP-730 was seen at the Cuban Embassy in Mexico City. The occupants of the car came to pick up Remiro Jesus ARREU-Quintana and Reynaldo CEPEDA-Hernandez, two Cuban Embassy CUIS Officials.

2. The source has identified the occupants of this vehicle as being identical with those who in the past have come in two different vehicles bearing Mexican plates. One of the vehicles has been identified as a 1963 Ford stationwagon with plates TTT-AP, which was issued to Moises FORCE-Cortes of Cabanas 62. Our Mexico City Office is still awaiting the identification of the owner of the other vehicle used, which was a blue Volkswagon with Mexico plates 669-SH. These two vehicles have been used in visits to the Cuban Embassy on 3 June and 9, 23, 24, and 28 November 1966 when ARREU and CEPEDA have been contacted.

3. Investigation revealed that the Texas plate was assigned to a 1966 Ford Mustang owned by Dr. J. N. GONZALES of 318 Saunders, San Antonio, Texas.

4. Credit and police checks were negative. The San Antonio telephone directory was checked and the results were also negative. A Credit Bureau source checked the City Directory and stated that there was no such address as 318 Saunders--the street begins in the 1100 block.

5. There was no identifiable information on Dr. GONZALES in the files of this Office, and was no information on Moises FORCE-Cortes in either our Mexico City files or in the files of this Office.

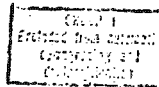





3. In October 1965, JONES was a student at the University of Tennessee.
4. An informant in the Southampton area advised that she has known JONES for many years. She added that he was born and grew up in the Southampton area and that he is married to the former Phyllis CANCELLIERI. He is a newspaperman now in Mexico. He used to work for United Press, but whether or not this is still his employer, she could not say. Before going to Mexico with his wife, he did newspaper work in South America and also in Florida. The informant said that JONES is a fine person, of excellent reputation, sound moral life and living habits, and a dependable U.S. citizen.

The New York City Telephone Directory does not list any THORNER at this address nor does the New York City Crisscross.

3. Upon review of the files of this Office, it was determined that our files reflect no additional information which is not already available to your Bureau. However, it appears that neither of the persons in the photographs forwarded by our Mexico City Office are identical with Dr. THORNER.

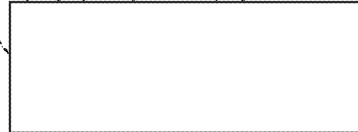

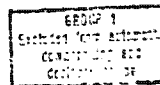

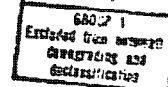

Records revealed his date of birth as being 29 June 1930 and his description recorded as: brown eyes and hair, six feet in height, 188 lbs and married. His address was indicated as 2104 South Crescent Heights, Los Angeles with a prior address as 2114 South Crescent Heights. Licensing records reflect that KATZ applied for and received California Operators' license H-749184 on 18 February 1959. This license expired in 1961 and was not renewed. He does not hold a current California Operators' permit. He previously held a Michigan drivers' license.

3. Files of this Office contained the following information on a Robert KATZ, who may or may not be identical with Subject: Washington Post 24 January 1952 news article reported that David AARON, a former government employee told House investigators that he and 32 other Southern California lawyers belonged to a Communist Party "legal cell" in Los Angeles from 1946 to 1948. Washington Post 24 January 1952 news article reported that David AARON, a former government employee, told House investigators that he and 32 other Southern California lawyers belonged to a CP "legal cell" in Los Angeles from 1946 to 1948. A Robert KATZ was on the list.

4. For your information, the following traces are on a Robert Maurice KATZ, who may or may not be related to Subject:

a. HMMA-1308, 2 November 1955. Soviet First Secretary KAZANTSEV made an appointment to see the Manager of France Press Robert Maurice KATZ (201-104222) at his (KATZ's) office, Bucareli 12 4th floor on 8 June 1955. On 5 August KATZ arranged to pick up KAZANTSEV at the Soviet Embassy to take him to lunch. The two appeared to be on very friendly terms.

b. HMMA-1450, January 1956. Re Robert Maurice KATZ contact with KAZANTSEV. Subject's date of birth was given as 1904.

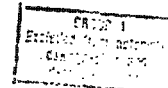



Old records indicated that in the years 1961 and 1962 SAVAGE held operators license #1213155. His date of birth was noted as 14 July 1934. There was no record of suspensions or any other violations for him which would have precluded issuance of an operator's license for 1963, 64 and 65.

3. With respect to whether the same individual would be the holder of both the temporary and permanent registration we were advised, yes, the automobile dealer has to issue a temporary plate in the owner's name, and it was the owner's responsibility to secure permanent registration within 30 days. Temporary and permanent registration, therefore, would be in the name of one and the same individual, Langston H. SAVAGE.

4. Title number was given as #E11440774. A search of the records indicated that assignment was out of file, for one of two possible reasons, police work, or transfer of ownership. On subsequent dates, up to and including 21 July 1965, this file could not be located for review.

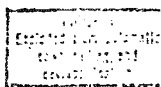

MILLS' DRIVER'S LICENSE, B 1087172, WHICH EXPIRED APRIL 1964, SHOWS HIS DATE OF BIRTH ~~1924~~ 4/2/40 - RESIDENCE ROUTE ONE, CAIRO, GEORGIA - PREVIOUS RESIDENCE ROUTE FIVE, BOX 393 A, TALLAHASSEE, FLORIDA. HE IS A WHITE MALE, HAS BROWN EYES, BROWN HAIR, 5' 11" TALL, 155 LBS., AND OCCUPATION SHOWN AS LABORER.

3. THE CREDIT BUREAU OF TALLAHASSEE HAS FILE ON MILLS WHICH SHOWS HIS ADDRESS AS 310 WALLACE STREET, TALLAHASSEE, FLORIDA. HE IS MARRIED TO EDITH AND AS OF JULY 1956, HE WAS EMPLOYED BY THE FLODINE COMPANY, QUINCY, FLORIDA. MILLS HAS THIRTEEN SEPARATE COLLECTIONS RANGING FROM \$4.75 TO \$125 DURING THE PERIOD OF 1958-64.

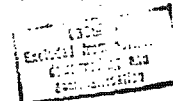

- Between the period 11 August and 20 August 1964, two unidentified men appeared at various times at the PERUVEN Embassy in Mexico City driving cars with U.S. license plates. The subject of photograph 1 (attached) arrived on 11 August in a red Chevrolet with California license plates number LJM 874 (black with yellow numbers.) He returned later in the day with an unidentified woman who remained in the car. He also visited the Embassy on 12, 17, 18 and 20 August.
- The subject of photograph 2 (attached) arrived at the Embassy on 14 August in a gray Oldsmobile with California license plates number OGZ 322 (color unspecified) and left the Oldsmobile at the Embassy. He returned to the Embassy on 15 and 16 August. Later on 16 August, both this man and the subject of paragraph one arrived at the Embassy at the same time.
- On 14 and 15 August, the Oldsmobile was taken out several times by four PERUVEN officials (IDENTITIES-A, B, C and D), and on one occasion, the car returned to the Embassy containing only an unidentified woman and her chauffeur.
- On 22 August, the Oldsmobile left the Embassy, and this time it bore license plates 251-D, which according to the LIFEPIES, were issued to IDENTITY-D in August 1964 for a 1957 Oldsmobile.
- It is requested that Headquarters provide the names of the owners of the two California license plates, along with any available traces; and that permission be given to pass this information to ODEINT.

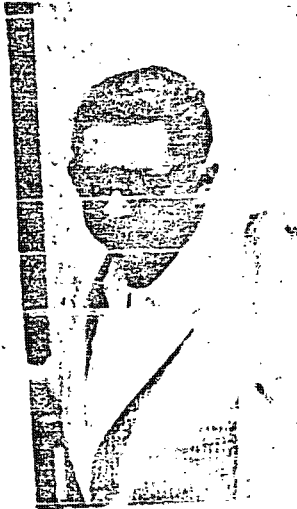

1. An attempt to determine the name of the owner of the white car bearing Texas licence plate WA 71-17, has resulted in the following information:

a. 1964 license plate, same number, was issued to Grady Olan HUGHES, 126 Carroll Street, Center, Texas, for use on a 1949 four-door Plymouth. HUGHES was listed as being 27 years of age, married to Marie HUGHES and as having worked as a mechanic at Perry Brothers Garage, in Center, Texas since April 1962. A report reflected he has an unsatisfactory credit rating and that he was not a good employee. Subject does not have a criminal record.

b. 1963 license plate, same number, was issued to Armando GONZALEZ, 801 Broadway, San Antonio, Texas, for use on a 1964 Olds F-85 Cutlass Holiday Coupe. On 9 June 1964 GONZALEZ was assigned license plate JL 22-16 which was placed on the above identified automobile. It was noted that GONZALEZ was two months late in registering his 1964 automobile as 1963 plates expired on 1 April 1964. Since the name Armando GONZALEZ is a common Latin American name, the Credit Bureau could not provide us with more identifying information. The San Antonio Police Department, however, supplied us with information on one Armando GONZALEZ, alias Richard GONZALEZ, Amador Gonzalez, Richard G. RAMOS; who was described as having black hair, brown eyes, 5'5", and weighing 135 lbs. He was supposedly born in Mexico and his age is unknown. This information consisted of a rather lengthy arrest record for drunkenness and arson.

2. There were no Headquarters traces on HUGHES. There were, however, numerous traces on Armando GONZALEZ, but we will require more information in order to positively identify him with any GONZALEZ in our index.
