GIVING THIS CONTINUED EMPLOYMENT, WE THINK HER ACCESS IS FAIRLY DESCRIBED AS GOOD IN REPORTS ABOUT THE ARMY. IN REPORTS ABOUT OTHER NON-ARMY TOPICS WE PROPOSE CONTINUED USE OF "INDIRECT" ACCESS IN HER SOURCE DESCRIPTION.
