DIFFERENCE IN RANK OR DUTIES. DAGGERS COMMENTED THAT THEY FOUND IT STRANGE THAT ANOTHER FORMER RUSSIAN EMBASSY OFFICIAL (A HARD-LINER) HAD RETURNED TO A FORMER POST SO SOON AFTER LEAVING, AND WITH NO APPARENT CHANGE IN DUTIES NOR INCREASE IN RANK.

DAGGERS HAVE NOT SEEN AT THE RUSSIAN EMBASSY SINCE HE LEFT ON HOME LEAVE.

 REGARDING THE CISN'S DECISION TO NO LONGER PROVIDE KDPEEK WITH
 THE NEGATIVES TAKEN FROM THE OP. D/2 STATED THE HUSTLES HAD
 INFORMED HIM OF THIS ACTION BY THE CISN ABOUT TWO WEEKS AGO.
 THE HUSTLES, AT D/2'S DIRECTION, MADE SUBTLE INQUIRIES AT CISN
