immediate investigation to determine whether there are any DIA  
agents in Miami. Any such agents identified should be immediately  
reported to the Bureau and separate investigations instituted.  
The objective of these investigations should be to determine  
whether their activities bring them within the purview of the  
Foreign Agents Registration Act of 1938, as amended. X<sup>u</sup>

Atlanta, which is office of origin in captioned matter,  
refer to its airtel 2/27/59 which noted subject indicated he  
would endeavor to obtain data concerning CP of Cuba and furnish  
it to Atlanta upon his return to that city. Upon Hughes' return,  
Atlanta immediately interview him concerning the indented  
information set forth above protecting the Army as the source. X<sup>u</sup>

For the information of Miami, the subject is an  
American and technical advisor for Cuban Air Force. He recently  
visited Atlanta to see his dying father at which time he was  
interviewed concerning his possible involvement in TGP case and  
his connection with Cuban revolutionary activities. Subject  
reportedly has been furnishing information to  
concerning proposed Cuban plans to invade Dominican  
Republic. The following is a description of the subject:
