Celso M. Hernandez - first saw LHO on Canal Street in New Orleans, La. passing out FPCC leaflets.


On February 14, 1978, at about 9 p.m., Celso M. Hernandez of 752 Oakwood Drive, Gretna, La. (504) 522-6301 was interviewed by this investigator at the home of Carlos Bringuier, 319 Terry Parkway, Gretna, La.

Mr. Hernandez could offer nothing of positive value to aid in this investigation. He reiterated his statements previously given to the FBI and verified that he was the secretary of the D.R.E., he was never at any training camps, didn't know LHO prior to Canal Street incident.

Photo book supplied by this committee was viewed by Mr. Hernandez, while in sequential order, numbered 1 to 110, Photos, #72/73 are missing.

Subject viewed photos twice, 1st viewing - "No identification", 2nd viewing identified the following: 23 - Carlos Bringuier; 57 - LHO.
