Dear Mr. Goff:

In connection with its investigation into the circumstances surrounding the death of President Kennedy, the Select Committee on Assassinations requests that duly authorized representatives be granted access to the following information:

- Names and addresses of the five Secret Service agents assigned to the Protective Research Section as of November 22, 1963 who had the responsibility for the Processing and Control of Threats, Investigations and Evaluations. Reference to these agents is made in Warren Commission Exhibit #761.
- 2) Names and addresses of all Secret Service staff members assigned to the Chicago and Miami Field Offices in November 1963. Please include the last known address of Chicago Office staff member, Charlotte Klapkoceski. The addresses of those Special Agents which have previously been provided need not be furnished again.
- 3) 1963 Secret Service files and records, including COS classified materials, stored at the Federal Record Center in Suitland, Maryland, with respect to communications between field office agents in the cities listed below, the White House detail, and Secret Service headquarters. Access is requested to only those documents relating to Presidential protection and security during the period, March 1963 - November, 1963.
