On <sup>12/11</sup>~~12/12~~/63, informants were invited to dinner at the home of KURT ODENHEIM, the only dinner guest other than informants being CHARLES SMALL. Informants advised that the dinner became very unusual since both SMALL and ODENHEIM vied with each other to prove their political thinking sound and their own leadership qualifications. BERTHE SMALL had gone to Cuernavaca with JEAN BUTLER where BUTLER has taken a home for the holidays and may remain permanently if the "experiment" works. (u)

CHARLES SMALL during the evening told informants that they naturally realized he is far more than just a jeweler. He urged them to cut donations to the PCM and to give money to the CP, USA, which may need the money "even more desperately than the Mexicans." (u)

CHARLES SMALL was questioned by ODENHEIM as to whether or not he knew LEE OSWALD. ODENHEIM said that he had bet that SMALL knew him. SMALL stated he had consulted his books when the first story broke in Mexico and he is sure that OSWALD must have been in the store because "you know everyone reports in there and he would have done so too." SMALL indicated, however, that fortunately when OSWALD was in Mexico, according to the newspapers, SMALL was out of the country. He said he has been carrying his "red book" ever since expecting momentarily arrest and can prove by it that he was in the United States at the time. (u)
