SYNOPSIB

Information obtained relative to the Church of the First Born of the Fullness of Time does not indicate its policies include the assassimation of top government officials and/or top officials of the Church of Jesus Christ of Latter-day Saints. Ralph Highee denied he made any statement indicating that these were part of the policies of the Church of the First Born of the Fullness of Time.

(A) IN TRODUCTION:

Reference is made to my previous memorandum report dated in the Salt Lake City Office on January 3.

(B) GENERAL INQUIRIES:

At the offices of the Church of Jesus Christ of Latter by Saints in City on January 16 interviewed Spencer Ma Kimbell ----Selt Lake City on January 16 interviewed Spencer W. Kimball, member of the Council of the Twelve Apostles, relative to the history of the Church of the First corn of the Fullness of Time, which is an apos tate group of the LDS Church.

Wr. Kimball advised that the LDS Church considers the Church of the First Born of the Fullness of Time to be a "cult organisation," and that any members brought to their attention are exponentalisated from the LDS Church. Approximately one year ago the doors of the LDS Temple in Salt Lake City were bombed. This resulted in some damage to the heavy massive doors as well as the force of the blast being deflected invert and causing minor damage inside the Tomple. Although this has never been proven or established, it is the thought of some officers of the Salt Lake City Police Department that members of the Church of the First Born of the Fullness of Time were responsible for the bombing.

Mr. Harigor accorded there is nothing in the file to indicate that Ralph Highes became involved in any difficulty while employed by the company, and from the information available he would be considered for rehiring.
