On 2/6/64, [MEX-18 and MEX-19 orally furnished the following information to the writer: (S)(u)

REVA and JOSEPH BERNSTEIN claimed that two persons from the Fair Play for Cuba Group in the United States have "disappeared" since the assassination of President KENNEDY, implying that these individuals had been kidnapped or murdered. The BERNSTEINS, however, did not furnish the names or further identification of those persons. (S)(u)

Informants also advised that LINDA DE VRIES, during the first part of February while the informants were in Cuernavaca, had stated that CHARLES SMALL had better be careful of his friends and who he associates with. She further stated that in connection with the assassination of President KENNEDY she did not know how long CHARLES SMALL thinks that he can stay out of trouble, implying therewith that SMALL was involved in some way with a person or persons connected with that crime. (S)(u)

The informants also advised that MANUEL BENNETT has, according to associates of the ACGM who have tried to locate him, disappeared since Christmas 1963. According to the informants, BENNETT has moved to a place unknown and given up a position that he liked. The informants pointed out that BENNETT had a reputation for being a expert forger of documents. (S)(u)

Informants also advised that REVA and JOSEPH BERNSTEIN claim they plan on leaving Mexico approximately 2/16/64 (S)(u)
