FOLLOWING IS DAILY SUMMARY:

RE ALLEGATIONS OF PEDRO GUTIERREZ VALENCIA. CIA HERE TODAY ADVISED REVIEWED RESULTS PHOTO SURVEILLANCE AT CUBAN EMBASSY FOR PERIOD SEPTEMBER AND OCTOBER LAST WITH SPECIAL EMPHASIS ON DATES SEPTEMBER THREE ZERO TO OCTOBER FOUR, COMPARING PHOTOGRAPH OF GUTIERREZ WITH PHOTOS OF PERSONS VISITING CUBAN EMBASSY DURING PERIOD DESCRIBED. CIA UNABLE TO IDENTIFY GUTIERREZ AS VISITING CUBAN EMBASSY DURING THAT PERIOD AND CIA OFFICIAL VOICED BELIEF THAT GUTIERREZ WOULD HAVE CERTAINLY BEEN PHOTOGRAPHED IF HE HAD IN FACT EXITED CUBAN EMBASSY ON OCTOBER ONE LAST BETWEEN ONE ZERO THREE ZERO AND ONE ONE ZERO ZERO AM AS GUTIERREZ CLAIMED.

CIA ALSO TODAY MADE AVAILABLE THREE PHOTOGRAPHS OF UNIDENTIFIED POSSIBLE AMERICAN FLOWN TO DALLAS ON NOVEMBER TWO THREE LAST BY SA ELDON D. RUDD AS WELL AS TWO ZERO PHOTOS OF POSSIBLE AMERICANS PHOTOGRAPHED AT CUBAN EMBASSY HERE DURING SEPTEMBER AND OCTOBER LAST FOR EXHIBIT TO GUTIERREZ. upheld per agency 7-28-83

CIA INFORMED PERSONNEL ON PLANT AT CUBAN EMBASSY HERE UNABLE TO IDENTIFY DINA RENAULT AUTOMOBILE WHICH ACCORDING TO GUTIERREZ

SINCE IT APPEARS THAT BRACELET AND POST CARDS WERE NOT PURCHASED AT SMALL'S STORE, NO FURTHER INVESTIGATION BEING CONDUCTED ALONG THIS LINE. (X) u
