LEE HARVEY OSWALD

On March 6, 1964 Detective Sergeant J. STANDISH, Grimsby Borough Police, Grimsby, Lincolnshire, interviewed Mrs. ROSETTA GELL, sister of ALBERT OSBORNE, at her residence 87 St. Heliers Road, Cleethorpes, Lincolnshire. Mrs. GELL stated she had seen her brother ALBERT briefly when he visited the Grimsby area in November 1963 but had only been to hor home for a few hours. She stated she had heard from him by mail earlier in the year when he indicated he was coming to Grimsby on a visit. She produced the letter she had received from ALBERT which bore the return address of Emilio Corranza 4A, Texmelucan, Mexico.

She advised she had heard her brother had been married in the U. S. but had no details regarding the identity of his family. She stated her brother lived with her as a young boy after their mother died but ran away from home to join the British Army, lying about his age, when he was about 16 years old. She further added it was about 47 years before she or any of the family heard or saw him again. At that time he printed a notice in the paper advising his family he was still alive and was returning on a visit. The only other time he has been back to Grimsby was his recent trip in November 1963./()

On March 6, 1964 Sergeant F, MAYS, Horncastle Station, Lincolnshire Constabulary, interviewed ARTHUR OSBORNE, brother of ALBERT, at his home, 14 Mill Lane, Marcham Road, Horncastle, Lincolnshire. ARTHUR advised that he, like his sister ROSETTA, had seen ALBERT very briefly during his visit to England in November 1963 and that he was of the opinion that ALBERT had been married and that his wife had been killed in an automobile accident, date unknown and that ALBERT had a son who was killed in World War II. The son was married and they had one child. However, it was ARTHUR's recollection that the son's wife had remarried and also the child, a daughter, is now married. According to ARTHUR he was of the opinion ALBERT had very little to do with the family now that both his wife and son were dead.
