In addition to the foregoing, there is enclosed an Autostat copy of a letter dated 11/29/63 signed K. WALEGORA, addressed to Asst. Legat McCRAY. The writer puts forth a theory that the assassination of the President was organized by the Soviet Secret Service. This individual is known to this office and to Special Branch, New Scotland Yard, as a mentally unstable chronic complainer, whose real name is KAZIMIERZ WINCENTY WALEGORA, born 3/4/15 in Poland. He is a disbarred attorney and came to England as a war-time refugee. He has contacted the U.S. Embassy and the police on numerous occasions in the past regarding his "problems."
