DALTON SMITH indicted 1/11/68 by East Baton Rouge, Louisiana, authority on a bill of information charging him with offering a \$65,000 bribe to EDWARD GRADY PARTIN to change his testimony in jury tampering trial of former Teamsters Union president JAMES R. HOFFA.

SMITH already under indictment for attempting to bribe AUBREY YOUNG, a former aid to Governor JOHN MC KEITHEN, to act as a middleman in the alleged scheme to buy HOFFA's freedom.

The bill of information is a legal device in Louisiana which by-passes the grand jury, and charge the bribe was offered 1/15/67.

The bill was filed at a hearing held on request by District Attorney SARGENT PITCHER to increase SMITH's bond from \$7,500 to \$25,000 in the YOUNG case. The bond was raised to \$12,500 and a bond of \$2,00 was set on the second charge.

GARRISON's KENNEDY Assassination Probe, was allegedly attacked by two Negroes in his hotel room. According to statement made by HICKS at a press conference, stated he did not think this attack had anything to do with his testifying before the Orleans Parish Grand Jury.

HICKS testified, according to press reports, that he saw President KENNEDY being shot and that one bullet passed over his head and struck a traffic caution sign, which was removed by members of the Dallas Police Force, according to HICKS. He said this was never mentioned in the Warren Commission report.

HICKS stated that the Negroes that beat him up was probably attempting to commit a burglary in his hotel room.
