Also, should it be learned that they were in Canada, our investigation will be extended to determine if, in fact, they were interviewed as stated. You will be advised promptly of our findings.

4. Meanwhile, we might mention that from a review of records at this Headquarters, no information was located which would in any way substantiate the statements made by Mrs. BERNSTEIN, indicating that she and her husband had been interviewed in Canada following the assassination of President Kennedy.

5. In keeping with your request, this matter is being handled expeditiously.
