2. Last year SHIRAKOVA visited the United Kingdom with a party of Soviet teachers, arriving on 2nd September and leaving on 30th September, 1967. We were thus able to discover her patronymic, and her correct age - in spite of telling our source that she was born in 1939, her birthdate was given on arrival here as 18th January, 1937! A copy of the photograph attached to her visa application is enclosed for your records. S

RIMMA X SHIRAKOVA

3. We have been in touch with our source who is friendly with this woman, and have confirmed that she spent a considerable amount of time with him while in this country. During this time he ingeniously or ingenuously, we are not sure which, took her to the Chamber of Horrors at Madame Tussauds' Exhibition, where of course there is a waxwork of Lee-OSWALD. This she instantly recognised, and told our source that she had known OSWALD, thus clearing up any doubts in our minds about this identification. S
