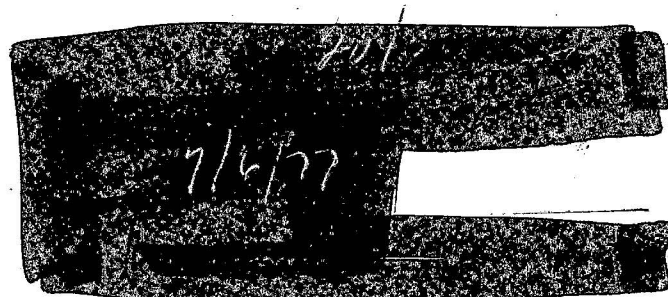

1. On 27 Aug 68, the file subject was interviewed at her home, Apt. 1, 191 Henderson Avenue, Ottawa. The interview was commenced with a request that the file subject provide details of her background. To this request, she supplied the following information:

Full Name: Ethelka SURANYI
Date of Birth: 13 Oct 1923
Place of Birth: Zsarajon, Hungary.

2. Subject also provided the following background information:

- a) 13-10-44: Married 1st husband, Lajos VAJI. Separated from him in Sep 1946. No children born during marriage with VAJI.
- b) After leaving first husband, had a boyfriend named (FNU) MOLNAR. A son, Imre MOLNAR (present age 19) was born through this relationship. Imre MOLNAR is presently in his 4th year of study as a chemist. File subject communicates with him by mail.
- c) 1949-1951: Resided with members of her family at Zsarajon, Hungary.
- d) 1951-1956: Resided in a rooming house in Budapest. Employed at a State Brewery in Budapest.
- e) Nov 1956: Escaped from Budapest to Vienna in the company of a Hungarian family from Budapest. (Unable to recall names of those who escaped with her.) Spent two weeks in a refugee camp in Vienna where she met William MICSKO () (also a Hungarian refugee.) Became pregnant during liaison with MICSKO while at Vienna. Were taken from Vienna to Paris.
- f) May 17, 1957: Arrived at Edmonton, Alberta by air (polar route) from Paris. Accompanied by William MICSKO. A few months after arrival in Canada, a son, Joseph SURANYI (MICSKO) (present age 11) was born. (Joseph presently residing with file subject.) File subject left MICSKO shortly after arriving at Edmonton when she learned that MICSKO already had two wives in Budapest.

- g) After leaving MICSKO, the file subject lived for a time with one Sandor CZUTAK () a friend of MICSKO's. CZUTAK is the father of the file subject's daughter Susan (present age approx. 9 years). The file subject claims that MICSKO and CZUTAK were in trouble with the authorities in Edmonton during Aug 1957 when they organized a demonstration against the Department of Immigration at Edmonton.
- h) Dec 1959: Left CZUTAK and proceeded to Saskatoon where she was under the care of the Welfare Department. Met Carl VARGA () in Oct 1960 and lived with him until Apr 1961. VARGA is the father of the file subject's daughter Erika (born in 1962).
- i) Apr 1961: Subject and her children left Carl VARGA behind at Saskatoon and moved to Tillsonburg, Ontario, where they stayed with a relative, Charles TUKACS () 79 Vermont Avenue, Tillsonburg. A few months later, VARGA found out where the subject was and he rejoined her. They then lived together at Lot 4, Con. 5, Ntr. Middleton, R.R. #5, Tillsonburg.

3. The file subject was then asked to relate her story with regards to Lee Harvey OSWALD (). She said that while she was in Paris (Nov 1956- May 1957), she was given a severe beating by William MICSKO. She claims that three other refugees witnessed this beating. These witnesses were Lazzlo SZEGEDI (), Lazzlo DGORGYORVICS () and another man that the source claims was Lee Harvey OSWALD. She claims that she did not know OSWALD's identity at the time and that he went by two nicknames "Tall Lajos" and "Red Lajos". She described this man as "quite tall with a reddish complexion and short hair". According to the file subject, this man was also a refugee from Hungary and he spoke Hungarian. The file subject claims that SZEGEDI, DGORGYORVICS and OSWALD flew from Paris to Edmonton on the same flight as hers on May 17, 1957.

4. The file subject claims that she also saw OSWALD at the Welfare Office in Saskatoon, Sask., in 1960 or 1961 and that he was on welfare at that time. She claims that while she was in Saskatoon, she heard that the "big boss" was in town. She learned a short time later that the "big boss" was Robert KENNEDY.

5. The file subject said that the next time she saw OSWALD was at Tillsonburg, Ontario, on Oct. 24, 1963. At that time, OSWALD stayed with Carl VARGA at Tillsonburg, for four days. According to

the file subject, VARCA and OSWALD purchased some winter clothing and left for Cadillac, P.O. to look for work. She claims that OSWALD and VARCA returned to Hillsonburg three days after the assassination of John F. KENNEDY.
