At 5:57 PM., 8/22/67, a telephone call was received from the Montreal, Canada, operator who asked if a collect call would be accepted from a Detective DAVID, Homocide Division of the Montreal, Canada, PD, who desired to speak with the individual familiar with the captioned case. (S)u

The operator was requested to ascertain Detective DAVID's full name and to advise him that arrangements would be made for him to be contacted by our liaison representative through our Washington headquarters. (S)u

The operator talked in French to the caller who also was speaking in what appeared to be French. The operator inquired as to whether he would be immediately telephonically contacted, at which time he was advised via the operator that arrangements would be made for him to be contacted at an early date. The operator determined that this was unsatisfactory and that he desired to call Washington headquarters himself, the number of which was furnished to the telephone operator. (S)u

Immediately thereafter, Supervisor C. W. LYLES, of Mr. ROSEN's Division, was telephonically advised of the possibility that the Bureau would receive a collect call from Montreal, Canada. (S)u
