Reference is made to your letter dated September 22, 1977, entitled "Assassination of President John Fitzgerald Kennedy - Willem Leonard Oltmans, Dimitur Adamov Dimitrov." Enclosed are two copies of a memorandum dated April 29, 1974, reflecting the circumstances surrounding the April 3, 1964, arrest of Dimitroff at Beverly Hills, California.

In addition to the enclosed information, our files reflect that Dimiter Dimitroff telephoned the Jefferson County Sheriff's Office at Golden, Colorado, January 14, 1961, inquiring with respect to any warrants outstanding for himself or his wife, Flora. During the conversation, Dimitroff stated that he was doing work for the FBI at that time. Our records indicate that at no time has Dimitroff been an employee of the FBI.

In December of 1971, a confidential, sensitive source of this Bureau advised that an individual identifying himself as General Dico Dimitrov was attempting to contact Israeli Ambassador, Yitzhak Rabin, in an effort to relay to Rabin some "Confidential" information. (S)
