TWENTYONE FIFTYEIGHT ONE GEORGE DE MOHRENSHELD PAREN (PHONETIC) PAREN TOLD BEATRIZ RODRIGUEZ, DOMINICAN EMBASSY, HE WAS FROM DALLAS, TEXAS, HAD SPOKEN TO THEN DOMINICAN AMBASSADOR TO THE U.S. MANUEL DE MOYA TWO DAYS PREVIOUSLY.
