SUAREZ was not notified of the Bureau's interest in subject LARIN, and advised that he first became acquainted with her in New York City, having met her at a social function there.

SUAREZ stated that LILIA LARIN is supposed to be the widow of Senor LARIN, a famous Mexican candy manufacturer "whose products are as well known in Mexico as Wri{ley's chewing gum in the United States." He advised that if she actually is this individual, she is undoubtedly a wealthy woman. SUAREZ stated that within the past week, subject LARIN had contacted him for the purpose of obtaining a letter to some officials in Paris, France, in order to arrange the immigration of a Polish family from France into the United States. She did not supply any particulars as to the identity of the immigrants, but stated that she would return at a later date, which she never did.
