HENRY J. DOSCHER, ATTORNEY, ABILINE, TEXAS, HAS ADVISED HE KNEW GEORGE DE MOHRENSCHILDT WHEN RESIDING IN ABILINE ABOUT ONE NINE FIVE ZERO AND THAT GEORGE DE MOHRENSCHILDT AT THAT TIME CLAIMED HE HAD BEEN IN BRITISH INTELLIGENCE DURING WORLD WAR II. (u)

INVESTIGATION HAS DISCLOSED GEORGE DEMOHRENSCHILDT HAS ESTABLISHED PROPENSITY FOR FALSEHOOD AND EXAGGERATION AND THAT HE WAS CLASSIFIED FOUR-F IN U.S. DUE TO HEART CONDITION. IN VIEW OF ABOVE, HOWEVER, AND INTEREST OF PRESIDENT'S COMMISSION IN PINNING DOWN BACKGROUND AND ACTIVITIES OF SUBJECTS, IT IS FELT SPECIFIC CHECK SHOULD BE MADE WITH APPROPRIATE BRITISH AUTHORITIES CONCERNING STATEMENT ALLEGEDLY MADE BY GEORGE DE MOHRENSCHILDT AS INDICATED ABOVE. EXPEDITIOUSLY ADVISE RESULTS AND SUREP. DALLAS ADVISED BY MAIL. (u)
